## GENERAL PRICE LIST

These prices are effective August 1, 2020 and are subject to change without notice.

Kleinberg Funeral Services, Inc. is independently owned and proudly operated by Steven J. Kleinberg.

The Federal Trade Commission (FTC) and the New York State Department of Health both require certain disclosures to be made by funeral providers on the General Price List. Although these disclosures are similar, they are not exactly the same. This General Price List contains both sets of required disclosures. The disclosures required by the FTC, when different from those required by the Department of Health, are preceded by the letters 'FTC'.

The goods and services shown below are those we can provide our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our services. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain in writing on the statement we provide describing the funeral services and merchandise you selected.

(FTC) The goods and services shown below are those we can provide our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

This list may not include prices for certain items that you select, such as cemetery charges or crematory services, flowers, and newspaper notices. The estimated or final prices for those items will be shown on the itemized statement describing funeral services and merchandise you selected. We charge you for our services in buying certain items.

The provider of funeral services is required to give price information in person or over the telephone.

Your authorization is required for a funeral home to obtain custody of the body and a body must be released promptly upon your request.

## Payment Policy

Kleinberg Funeral Services practices transparency in everything we do. To prevent any misunderstanding regarding payment of funeral expenses we have established a uniform payment policy. This policy allows us to exercise sound business practices, treat every family honestly and fairly, provide 24/7 care, and maintain an accessible, beautiful facility where families are comfortable gathering for services.

We are committed to supporting grieving families by creating meaningful and appropriate personalized tributes to honor their loved one's life. Our continued goal is to provide the respectful, quality service to which all our families have come to expect and are entitled to.

Kindly let us know in advance if you are experiencing undue financial hardship so we can tailor a service to fit your budget. We will never compromise a dignified funeral service as we can offer alternatives and options for any situation.

Please note that payment in full is expected after arrangements are completed and before services can be scheduled or obituaries placed. During the arrangement conference, you will be presented with a contract itemizing the goods and services you have selected.

You may apply any of the acceptable payment options individually or in combination.

**Cash, Personal Check, or Bank Check**

The deceased's name [alone] cannot be on the check.

You must be a signer on the account the check is being written on.

---

**Credit Card**

All major credit cards accepted: VISA, MasterCard, American Express, and Discover.

Credit cards are not accepted for cemetery expenses.

---

**e-Check or ACH payment**

You can transfer funds directly from your bank account to pay for funeral services.

---

**Insurance Assignment**

Payment with an assignment of a valid verified insurance policy. We do not accept policies that cannot be verified, insurance policies under 2 years old that are contestable, or any work-related insurance that cannot be assigned.

We rely on Tribute Insurance Assignments, LLC to process assigned insurance policies. A processing fee of 4.0% will be added to the assignment.

**Prepaid Funeral Trust**

We accept prepaid funeral trusts written by ANY New York State funeral home however, we reserve the right not to honor their prices. If the trust was not paid in full before death the outstanding balance can be paid by one of the acceptable payment options. We do not honor 'guaranteed' cash advances.

---

**Financing**

We are unaware of any third-party funeral lending companies permitted to do business in New York State at this time. You may wish to contact your banking institution for a personal loan.

---

**Estates**

Due to the uncertain time frame, it takes to administer estates we do not offer this as a payment option. You will be responsible for payment of funeral expenses through the above payment options and they may petition the estate for reimbursement.

---

***An Interest rate of 1.5% a month will begin to accrue 30 days after the arrangement date on any unpaid balance not assigned. After 60 days, any balance not assigned will be turned over to collections.***

**ALTERNATIVE SERVICES:**

Alternative services will be performed at the convenience of the provider. The following charges for direct burial and direct cremation do not include additional items or services, merchandise, facility use, and livery that the customer may wish to select.

**Direct Cremations:**

Prices range.....from \$2,100.00 which includes the local transfer of remains to the funeral home, staff services, securing of necessary authorizations, basic local transportation to the crematory, an alternative container for cremation, and the return of the cremains to the funeral home.....to \$2,000.00 which includes the services as described above, but with the cremation container supplied by the customer.

If you want to arrange a direct cremation, you may use an unfinished wooden box or an alternative container. Alternative containers can be made of materials like heavy cardboard, pressed wood, or composition materials (with or without an outside covering) or may be pouches of canvas or other materials. The direct cremation charge does not include the crematory charge.

**Direct (Immediate) Burials:**

Prices range.....from \$3,200.00 which includes the local transfer of the remains to the funeral home, staff services, securing of necessary authorizations, basic local transportation to the cemetery, and an alternative container.....to \$2,850.00 which includes the services described above but with the alternative container supplied by the customer. The direct burial prices do not include cemetery charges.

In New York State, embalming is not required by law. If you do not want embalming, you have the right to choose an arrangement which does not require you to pay for embalming such as direct cremation or direct burial. If you select certain funeral arrangements such as viewing or an open casket funeral, embalming may be required by the funeral firm.

(FTC) Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

**Other Preparation (Excluding embalming but including use of the preparation room):**

Preparation of the remains, unless selected, is not required for direct cremation or direct burial.

(FTC) This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

This charge does not include shipping charges or additional items of service, merchandise, facility use, and livery that the customer may select.

**Transportation beyond the local point of shipment:**

This charge will be billed either as livery or common carrier charges depending on the forwarding location. The local point of shipment is either JFK or LGA Airport.

**Receiving of remains from another funeral home:**.....\$2,000.00

This charge includes basic local transportation of the remains to the funeral home and/or place of local disposition, staff services, and securing of necessary authorizations. The charge does not include additional items of service, merchandise, facility use, and livery that the customer may wish to select.
